- **3. An Essay (containing no more than 500 words).** Describe your life and how you will use your education to improve your community. Share your current and past community and church involvement; awards and honors received and tell us about your educational and career goals.
- **4.** In addition to the above required items, have your school counselor submit a **certified/official Academic Transcript or Record of Grades** from the ninth through the first semester of the senior year to include cumulative Grade Point Average (GPA). Mail to the address indicated below or you may include a sealed envelope in your packet.

When all application submission requirements are completed, submit your application package by April 13, 2012 to:
